The Member

2. 3. Agrees to be liable for any damage to the property, injury to the member, disability, death or loss that occurs directly or indirectly through the use of vehicles, facilities, services or the circuit.
4. Agrees to indemnify the club for any damage to the property, injury to the member, disability, death or loss that occurs directly or indirectly through the use of vehicles, facilities, services or the circuit.
5. Agrees to indemnify and will not hold the club liable or responsible for any damage to the property, injury to the member, disability, death or loss that occurs as a result of ant less than satisfactory condition of property, vehicles, facilities and services if there are any to be found.
