5. Agree/s to assume all risk in or about the driving, racing and being a spectator of Sprint Karts and HEREBY RELEASE/S The Club from AND WARRANTS NOT TO SUE The Club in connection with any and all damages, claims, rights and causes of action of whatsoever kind of nature based on any damage to property, injury or disability to myself or another or the death of myself or another or any other loss arising directly or indirectly out of any use or intended use at any time of any vehicles, facilities, services of or associated with The Club or ANY OTHER CAUSE, whether or not I am on the property of The Club and whether or not the damage to property, injury, disability, death or loss was caused by the negligence of The Club, its agents or employees or any other person.
